MEMORANDUM FINA – 05.03.2014 Obligations des Fédérations Nationales («Member NFs»)

De KBZB vestigt de aandacht van de regionale federaties, van de clubs, van de atleten en van alle onder de bevoegdheid van de KBZB vallende organen en personen op de volgende na te leven bepalingen uitgevaardigd door de FINA.

La FRBN attire l'attention des fédérations régionales, des clubs, des athlètes et de tous les organes et personnes ressortissant de la compétence de la FRBN sur les dispositions édictées par la FINA devant être observées.

1) C 7.3: "The constitution and rules of a Member must not be in conflict with those of FINA. Where there is a conflict, FINA Rules shall prevail."

2) C 7.4: "Members must seek approval of the FINA Bureau for any change of name and/or constitution before such changes are valid."

3) C 7.5: "Each Member shall acknowledge in its national rules that FINA is the only recognised body in the world which governs Aquatics internationally."

4) C 8.2.1: "All Members are obliged to support FINA in its efforts to achieve its objectives."

5) C 8.2.2: "All Members are obliged to act in accordance with the decisions of the FINA Congress, the FINA Bureau as well as the FINA Rules."

6) C 8.2.4: "All Members are obliged to include within its constitution a provision, which allows out-of-competition doping, control by FINA."

7) C 8.2.5: "All Members are obliged to insert in its constitution, rules and regulations such provisions as may be required by the FINA Rules."

8) C 8.2.6: "All Members are obliged to manage its affairs independently and not be influenced by third parties."

9) C 8.2.7: "All Members are obliged to participate in international Aquatics' Competitions especially in the FINA World Championships and other FINA competitions."

10) C 8.2.8: "All Members are obliged to hold elections at least every four years, to notify FINA of the dates and the location of the elections, and to provide the minutes of its congress to FINA no later than 60 days after conclusion of the congress."

11) C 8.2.9: "All Members are obliged to ensure that their own members comply with the FINA Rules, regulations, directives and decisions of the FINA bodies."

12) C 27: "Disputes between FINA and any of its Members or members of Members, individual members of Members or between Members of FINA that are not resolved by a FINA Bureau decision may be referred for arbitration by either of the involved parties to the Court of Arbitration for Sports (CAS), Lausanne. Any decision made by the Arbitration Court shall be final and binding on the parties concerned."

13) DC 14.1: "All Member Federations shall comply with these Anti-Doping Rules. The regulations of Member Federations shall indicate that all FINA Rules including Anti-Doping Rules shall be deemed as incorporated into and shall be directly applicable to and shall be agreed to and followed by Competitors, Competitor Support Personnel, coaches, physicians, trainers, managers, officials, medical or paramedical personnel, team leaders, and club and Federation representatives under the jurisdiction of the respective Member Federations."
